Penalty for Hunting without Permission

The maximum penalties for hunting without written permission for the first offense are 60 days in jail and up to a \$500 fine. For the second offense, the penalties are up to a \$750 fine, 90 days in jail, and/or loss of firearms or other hunting implements. A person must carry written permission at all time while engaging in hunting or trapping on private land and exhibit it upon request to a state wildlife officer, owner of the land, or the landowners authorized agent.



The automated game check process must be completed by 12:00 noon the day after the kill. If a deer is killed on the last day of a season, then it must be checked in by 11:30 p.m. on the day of kill.

Butchering / Meat Processing / Taxidermy

- The game-check confirmation number must be given to and kept by the butcher while he or she has the animal and meat.
- You must keep the game-check confirmation number until all the meat is consumed.
- · If you give the carcass to a taxidermist the game-check confirmation number must remain attached to the carcass. The game-check confirmation number can be written on the skull plate or taxidermy mount.

Instructions and Tips

Carry Your Permit:

You must carry your permit when hunting. Cut along the dotted lines and fold to credit card size for easy carrying.

Tag It: Make a game tag and attach it to the animal.

- Immediately upon harvest and prior to moving the carcass, you must attach a game tag to the animal.
- You will make your own game tag and it can be made of any material that you can legibly write on using an ink pen or waterproof permanent marker.
- The game tag must include:

Your full name Date of harvest (Month/ Day/ Year) Time of harvest (Hour: Minutes: am or pm) **County of harvest**

- You must also write this information on your permit in the spaces provided. Do not use this permit as a game tag.
- After you attach the completed game tag and write the information on your permit, you legally possess the animal and may transport it to its final destination.

Check It: Get your game-check confirmation number.

• To check your game and receive your game-check confirmation

- You will need your permit number and date of birth to get your game-check confirmation number.
- At the end of the game-check process you will receive an 18-digit game-check confirmation number.

You must record this number on your permit and attach the number to the animal.

You may write this number on your attached game tag.

The automated game check process must be completed by 12:00 noon the day after the kill. If a deer is killed on the last day of a season, then it must be checked in by 11:30 p.m. on the day of kill.
